<p>Population of Focus: Students grades 7th -12th in the two school districts within Adams County to reduce underage drinking.</p>								
<p>Statement of the Community's Readiness to Address the Problem of Practice: We conducted interviews with eight key local leaders during our community readiness assessment and in scoring our interviews determined we are in the stage of "Vague Awareness". Members of our Prevention Data Committee participated in the readiness assessment interviews and scoring. The PDC plays an important role in addressing underage drinking.</p>								
<p>Theory of Community Change: If we implement an effective Talk, They Hear You Campaign, then we can expect to increase the parental knowledge and skills needed to discuss underage drinking along with increasing the parental disapproval of underage drinking. If we increase parental knowledge and skills needed to discuss underage drinking along with increasing parental disapproval of underage drinking, then we can expect the youth to report an increase in family communication regarding the dangers of tobacco, alcohol and drug use as evidenced in the OHYES! survey results. If there is an increase in family communication regarding the dangers of tobacco, alcohol or drug use, then we can expect a reduction in underage drinking as evidenced by youth who report consuming alcohol in the past 30 days as evidenced in the OHYES! Survey results.</p>

<p>Description of Problem of Practice</p> <p>Underage drinking with both males and females, among 7th through 12th grade students in Adams County/Ohio Valley School District and the Manchester Local School District.</p> <p>Data to Support the Problem of Practice:</p> <p>The 2017 OHYES! Data indicated that underage drinking in the past 30 days for 7th through 12th grade was 14.9%. We had a huge jump from 10.6% in 8th grade to 32% in 12th grade, which is a 33% increase.</p>	<p>Description of Intervening Variable</p> <p>Family communication around alcohol use</p> <p>Parental disapproval of underage drinking</p> <p>Data to Support the Intervening Variable:</p> <p>The 2017 OHYES! Data showed 41.2 % of youth answered yes when asked if your parents have talked to you in the past 12 months about the dangers of tobacco, alcohol or drug use. The 2017 OHYES!
